Client will wear masks during their day in school as expected prior to the quarantine. Clients upon entering the school will sanitize their hands with available hand sanitizer. Clients will be required to maintain a social distance in the classrooms as best as possible. Prior to the dismissal of clients for lunch in the manor the clients will sterilize their area of use. Clients at classroom switches will sterilize their area of use before going into the next class. Upon dismissal for the day clients will sterilize their area of use.
- 2. How will the LEA ensure continuity of services, including but not limited to services to address the students' academic needs, and students' and staff members' social. emotional, mental health, and other needs, which may include student health and food services? Clients upon entering the manor for lunch will be required to use the hand sanitizer station near the entrance to the dining hall. Staff must station themselves ahead of clients before allowing clients to enter the manor and station themselves at the hand sanitizer station ensuring that all clients upon entering utilize the station. Clients who attend school on grounds will be required to wear their mask at all times other then sitting down while eating. At anytime the client gets up from their table they must put their mask back on. LRP clients who attend school on grounds will go through the line first and then upon receipt of their food go directly to the Manor Board Room to eat. Dorm clients upon receipt of their meal will eat in the dining area and social distance as best as possible. Masks must be worn while going through the food line. Kitchen staff will serve the food on paper plates and bowls for salads. All condiments will be served in condiment cups. Client should only have to pick out their milk. At the completion of lunch staff will sanitize the areas where clients ate at with a disinfectant spray. Clients upon the departure from lunch must sanitize upon their return to school.
